BREXIT Twenty Months On

So, let us list the benefits and positive changes that have occurred since the United Kingdom left the European Union.

- Chaos at the ports for exporting and importing goods due to increased paperwork, health & safety checks, etc., etc. resulting in delays and increased costs thus prompting some companies to abandon exporting to Europe.

Reflections on BREXIT

As expected, there was a lot of confusion from 1st January 2021 due to the government being unprepared and offering little help to business. Delays at ports ensued and Companies were faced with mountains of extra paperwork. Now more problems are coming to light. With Scotland and Northern Island voting to remain in the European Union one can now envisage Scottish independence and a united Ireland. So the 'United Kingdom' will become just England & Wales or perhaps 'New Britain'. Sadly, most of the English (like the UK's BREXIT government) don't care.

So, what have other impacts have there been?

- Buying some goods from Europe will incur vat (20%) and import charges.
- The UK has withdrawn from the student exchange scheme thus not providing the opportunity for students to broaden their knowledge and help their language skills.
- Musicians and artists touring the continent "will be required to check domestic immigration and visitor rules for each member state in which they intend to tour". This may require them to have multiple visas or work permits, which some industry experts say will be expensive and potentially prohibitive especially for musicians at the start of their careers.
- Plans are to scrap the EU's labour laws, which could be detrimental to the UK's workforce.
- The financial industry is now losing out in that over 7,000 city jobs have been lost to the EU with more to come.
- Travelling to Europe on holiday will become more onerous without the freedom to travel between member countries so easily.

Oh, and let's not forget that the UK still has to pay the EU £25bn!

Maybe things will not be as bad as predicted, but it still remains unfortunate that we have distanced ourselves from our historically close neighbours. It is also sad that we have a government that was pally with the United States' worst president in history — and is now trying to distance themselves from him! When can we get rid of this incompetent bunch!

BREXIT

(BRitain Exhibits Xenophobic and Insular Tendencies)

Throughout its history Britain has been closely involved with the European mainland and strongly integrated into its political and trading relationships. It has been invaded by Romans, Vikings and

more importantly Normans. It has taken part in many European wars, in both defence of its own territory and in aid of its European allies which culminated in the Second World War. Most of these wars were conducted during the era of Nation States. In the aftermath of the Second World War with its loss of over 60 million people European nations decided to forge a unity block designed to prevent future wars and move away from the Nation State mentality. Thus was formed the European Coal and Steel Community an organization of six European countries created after World War II to regulate their industrial production under a centralised authority. It was formally established in 1951 by the Treaty of Paris, signed by Belgium, France, Italy, Luxembourg, the Netherlands, and West Germany. The ECSC was the first international organisation to be based on the principles of supra-nationalism, and started the process of formal integration which ultimately led to the European Union (EU).

What has been the impact of the EU?

- Elimination of conflicts between nations that might have led to war.
- The spread of democracy and democratic values throughout Europe.
- Resolution of disputes via a common European body.
- Adoption of trading and other standards across Europe.
- The ability of Europeans to settle and work anywhere within the European area.
- Exposure of all Europeans to different cultures.
- Easy of travel for both business and pleasure.
- Ease of moving goods (tariff-free trading) between members of the bloc.

Granted, each nation must pay into a European budget to fund not only the organisation but to help increase the living standards of poorer members. Spreading such wealth across Europe in this way encourages local entrepreneurs and development and minimises the need for masses of poorer citizens to seek employment in wealthier member states.

Unfortunately, when the referendum on BREXIT was held neither 'Brexiters' nor 'Remainers' clearly presented the benefits and economic impact of leaving or remaining in the EU. In particular, the Brexiters appeared to have no plan as to how the UK would leave the EU and their campaign was based on three claims:

- 1. Reducing immigration
- 2. Taking back control
- 3. Eliminating our payments into the EU
